Component #1: Point Of View

What's this element?

The author is using point of view to show what the other characters are thinking. Different points of view show different ways that someone or something can or is being observed.

Why does it matter?

The author uses this to give you an insight on Cassia, Xander and Ky's personal opinions and what they are thinking. A way the author, Ally Condie, does this in the book is by writing each chapter in a different person's point of view. She also shows each one of their feelings when an event happens in their lives.

The first chapter is in Xander's point of view.

" I smile and he does, too. Because the Official is me"

The second chapter is in Cassia's point of view.

"Ky said he'd meet me tonight, by the lake"

The third chapter is in Ky's point of view.

"When I first came to this camp, I worried that the rising might use us like decoys the way the society did."

What's the impact on the reader?

This element gives you a different perspective on the events that are happening in the book. This can be very confusing at first because throughout the chapter you have to remember who's point of view it is in. Later on in the book it becomes very useful depending on what is happening. You can see how this element helps because if you did not see everyone's point of view you might have had a different opinion or bias. The author also wants us to see a different point of view so we can come to our own conclusions instead of the narrator telling you what to think.

Component #2: Narration

What's this element?

Narration can be reliable or unreliable, the author has provided a reliable narrator. The author has given us a reliable narrator so that we can trust that everything that the character is telling us is true.

Why does it matter?

We see a reliable narrator created by the author who is very useful because you can trust everything he/she says. The characters open up to us which shows their honesty.

"Those were the hardest words I've ever had to write" (177)

"I want it so much I think it might destroy me." (183)

"This is it, my greatest fear." (305)

What's the impact on the reader?

This element gives the reader a sense of relaxation. Now we do not have to worry about not having the full truth while the narrator is telling the story. The author does this so that you can follow the story line more easily.

Component #3: Descriptive Sentence

What's this element?

The author is using a very descriptive sentence structure. A descriptive sentence gives you a lot of details about a certain thing. Ally Condie does this so that you can paint a picture in your mind and have a clear image of what is going on in the story.

Why does it matter?

This is a very important element, because when you first meet a character you would like to know what he/she looks like so that you can imagine the scene in your mind. It also makes the story easier to follow and more interesting to read.

In the story, what effect did component two have on the reader?


